SPORTSMANSHIP, ETHICS, AND INTEGRITY REGULATIONS

In order to ensure that all participants in the District's extra-curricular activities are aware of the District's expectations regarding sportsmanship, the District administration shall publish the policy as follows:

- 1. By printing policy 4205, "Sportsmanship, Ethics, and Integrity" in all Mary M. Knight activity programs.
- 2. Publishing the policy in the student handbook.
- 3. Publishing the policy in the District's monthly newsletter in September of each year or at other times as necessary.
- 4. Occasionally posting the policy notice in prominent locations throughout the school.

Actions to be taken in respect to violations of this policy:

- 1. Upon the first infraction of the standards stated in this notice, the district shall issue the violator <u>one verbal warning</u> and notification of said policy.
- 2. Upon the second infraction of the standards stated in this notice, the violator will be asked to immediately leave the premises and the District shall suspend the violator from all remaining activity events for the current season. For example, if the incident happens at a basketball game, then the person will be suspended for the remainder of the basketball season.
- 3. Upon the third infraction of the standards stated in this notice, the violator shall be prohibited from attending all Mary M. Knight activity events for one (1) year. This includes all extracurricular events, for example: sporting events, sports banquets, and awards banquets.
- 4. The policy is to be administered and enforced by all members of the Administration/and or designees and they shall be allowed and authorized to use the assistance of any local Law Enforcement Agency if necessary to assist them in enforcing any or all provisions contained herein.

It is the policy (policy #4205) of Mary M. Knight School District No. 311 that all participants and observers of extra curricular activities are expected to demonstrate the same level of responsibility, respect and behavior at practices and competitions whether at home court or away activities, as is expected in the classroom. Athletes, coaches, participants and fans may not use language that is vulgar, lewd, disrespectful, or derogatory at a District extra-curricular event. Prohibited conduct includes language and/or behavior that is disrespectful or derogatory towards athletes, coaches or fans.

Violations:
