FLASH ALERT

Mary M. Knight subscribed to an emergency notification network called "Flash Alert." This system allows us to inform television and radio stations of emergency school closures or delays. You may self -register and manage up to three home or office email addresses and receive emergency information moments after we post it, at no cost to you.

To get started, go to <u>www.FlashAlert.net</u> and click on our region on the map, we are in the Seattle/Western Washington region category.

Under choose from these Organization Categories choose the Kitsap and Mason County Schools. Then choose Mary M Knight SD. You start the subscription process by filling in your email address.

You may enter one or two more email addresses. After entering them, you will launch a validation message to each address. Obtain the two-letter code in the message and post it back into your account to validate that address (or click on the provided link). This is done to make sure that your messages will reach you.

All addresses registered on FlashAlert will remain confidential. Once a year, you will receive an email at your registered email address asking if you wish to continue your subscription.

We will also be using the Blackboard Connect System that will call all the primary phone numbers that we have on file for families with the recorded message. This lets us add another layer of communication to try to make sure we reach everyone. If you wish to opt out of the automated call, please let us know and we will remove you from that service.



$\ensuremath{\mathsf{Q}}\xspace.$ When do we tell parents and students? Are we telling them what date to come to school?

A. We plan to start a communication plan with parents the first week of November. We are just focusing on the K-2 parents, so it is a smaller group. As soon as we have our plan together and the County is closer to the moderate category, we will start that communication plan. We know this is not perfect in that we will not be able to give parents a 15 or 30-day notice. I think parents are more than ready to send their children back, but I think that there will be many questions we have to be prepared to respond.

Q. What about those parents who do not want to send their children back to in-person instruction?

A. In the Hybrid model, we are still offering the remote learning day on Wednesday for all students. Parents/students can access instructional materials assigned in Google Classrooms and we can deliver additional instructional resources as needed, Part of the planning process is how to best "connect" with students on the days they are not attending in person. We want to offer some flexibility to those families who do not want or are not ready to bring their children back to in-person instruction.

Q. When will I know if my child is scheduled as an A-Day student or a B-Day student?

A. We will begin contacting parents the first week of November on what day their child is scheduled to attend.

Q. Will my children be attending school on different days?

A. No, we plan to have families attend school on the same days to keep families together as we look at phasing back in more students.

Q. When would High School Students come back?


A. In this phased in approach, High School students would be the last group to phase back to in-person instruction. If the COVID activity remains low, HS students could possibly resume school in the Hybrid model in early December. We have some different planning needs with HS students since they see multiple teachers each day and move between multiple classrooms each day with their schedule.

I hope that this answers some of your questions. We do want to bring back students for in-person instruction. However, we need to do this safely and in small steps.

Dear Community,

As we enter the month of November, we have been working with Mason County Health and the Depart of Health to develop plans to resume in-person instruction at Mary M. Knight. We have been utilizing the distance-learning model since the beginning of the school year. However, the COVID-19 activity in Mason County is currently decreasing and based on the trend data, the county may reach the "Moderate" level of active cases based on the Department of Health COVID-19 Risk Assessment Dashboard.

If this trend continues, we plan to bring back students for inperson instruction on a limited basis, starting with primary grades, possibly as early as the second week of November 2020. That could be as early as Thursday, November 12, 2020.

On October 22, 2020, the MMK Board of Directors approved this phased in approach to resuming in-person instruction when the county reaches the "Moderate" category for COVID-19 activity.

The first group of students would be our Kindergarten, First Grade, and Second Grade students in a Hybrid A/B Learning model. The A/B model was originally approved to start the school year.

We would be scheduling 50% of our Kinder, first and second grade students to attended school in person two days a week, and would continue with our distance learning model every Wednesday.

This limited model of A/B allows for us to have very small class sizes, allows for us to take all of the health precautions, and would allow us to offer in-person leaning two days a week to each child while continuing to offer instruction remotely on the days when students are at home.

approach to resume in-person instruction

Q. What is a phased in approach?

A. We would start with grades Kinder, First and Second grade in the Hybrid A/B model. This model was adopted back in July to start this school year, but we were recommended not to begin the year in this model but instead implemented full distance learning due to high COVID activity.

This phase in approach is recommended by the Department of Health in their revised School Decision Tree that was published on October 6, 2020. The intent is to start with primary age students. After at least three weeks with a group of students and the COVID activity remains in Moderate range and if there are no outbreaks at the school, we would look to phase in more students.

Q. What is the Hybrid Model?

A. We would have 50% of students on campus four (4) days a week. Every Wednesday, we would continue with distance learning. K-2 students would move to the Hybrid A/B in this first phase, the rest of the students (3-12) would remain in the current distance learning model for three weeks until we can add more students.

Q. When do we start? What is the Date?

A. As soon as the county reaches the "Moderate" category definition for COVID-19 cases. That means that we have to reach 75 cases or less per 100,000 over a 14-day period. We are tentatively looking at November 12, 2020.

Q. When do we reach moderate?

A. As of today (10/30), the County Official rate is 80 per 100K. The unofficial rate is 49 per 100K as of 10/30. The trend data is demonstrating a decrease in cases and we may reach or obtain the Moderate definition the first part of November.

Q. Why don't we just announce a firm date, like November 2 or November 9 like other school districts have done?

A. This downward trend in COVID Activity is a projection. If everyone continues to wear a face covering in public, socially distance, and limit travel outside of his or her homes, this downward trend data may continue. I want to avoid what many school district have done and announce a re-entry date two or three week out, and then suddenly have to retract or cancel a return date the weekend before the published opening date.

I do not want to build up false expectations and then have to retract last minute. To use a sports analogy, I do not want to have to "Punt the ball on first down".
